




## PLAT MAP OF 260 ACRE HOTZ FARM WILTON TOWNSHIP, WILL COUNTY

# FSA MAP OF 120 ACRES NORTH SIDE OF BARR RD. WILTON TOWNSHIP, WILL COUNTY





#### SOIL MAP OF 140 ACRES NORTH SIDE OF BARR RD, WILTON TOWNSHIP





### TOPOGRAPHICAL MAP OF THE 120 ACRE NORTH SIDE OF BARR RD IN WILTON TOWNSHIP





#### SOIL MAP OF 120 ACRES SOUTH SIDE OF BARR RD, WILTON TOWNSHIP





### TOPOGRAPHICAL MAP OF THE 120 ACRE SOUTH SIDE OF BARR RD IN WILTON TOWNSHIP




