Location Description: This 40 acre farm is located 3 miles south of Gardner, IL along S. Storm road. The I-55 interchange, which leads to Springfield to the south and Chicago to the north, is just west of downtown Gardner.

Site Description: The 40 acre farm is relatively flat. It has a small section of wetlands in the southeast section. Better detail can be seen in the Wetland map in the photo gallery of the brochure.

Side of Street: The farm sits on the south side of Stonewall Road and west of Storm road.

Highway Access: The I-55 Access in Dwight is 9 miles to the south and west of the property and the Gardner interchange is 3.6 miles to the north.

Road Type: The Storm Road is asphalt construction.

Property Visibility: The farm has 1320 feet of frontage on S. Storm Road.

Largest Nearby Street: This property sits on Storm Road just east of Campus road which leads directly south from Gardner.

Transportation: The closest airport to this parcel is Midway Airport in Chicago which is 31 miles. Grundy County, has Grundy Transit System which is a service that will take you anywhere in Grundy County and will also take riders to Joliet where you can take the Metra Train to the Chicago or several suburbs.

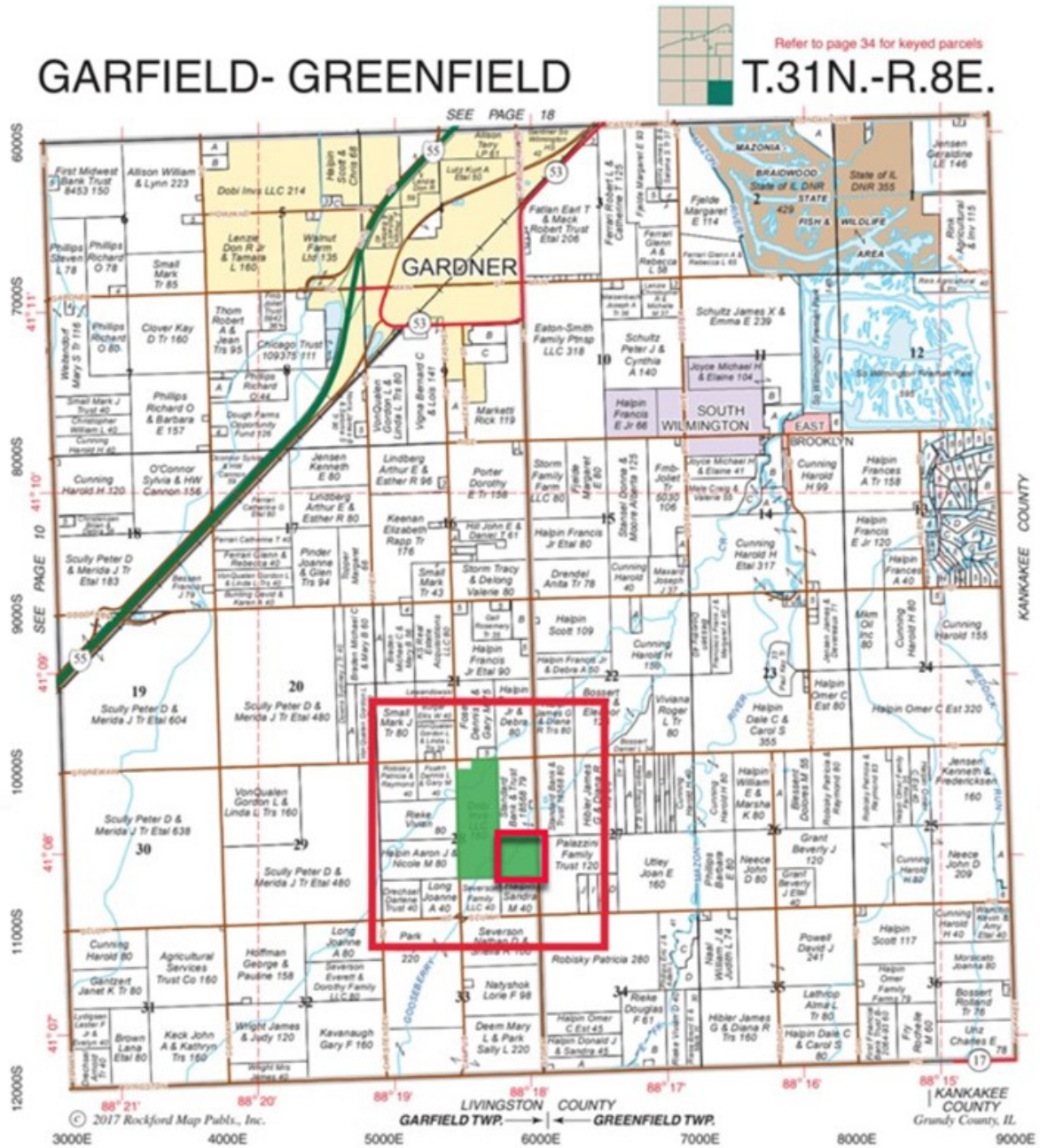

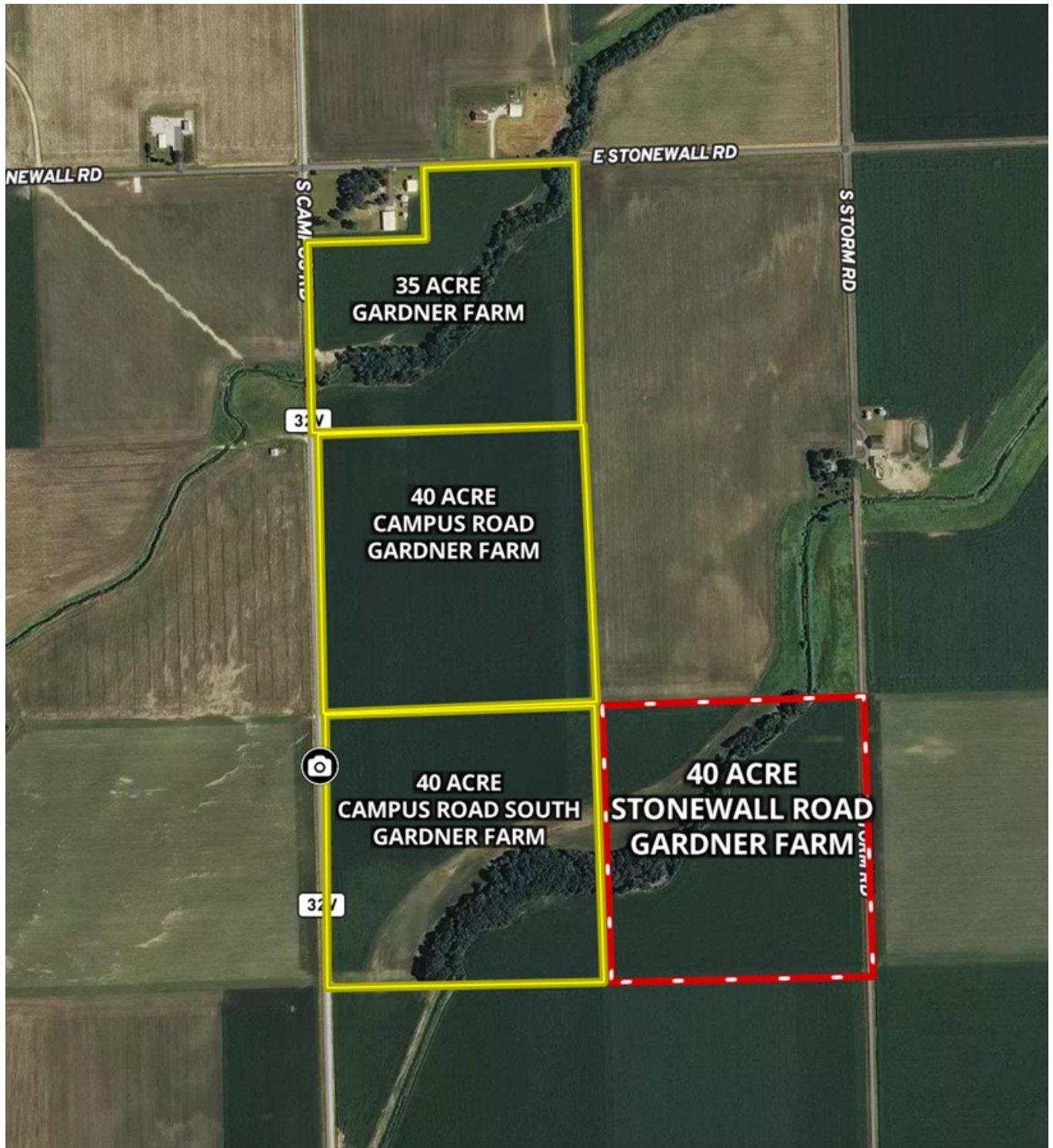

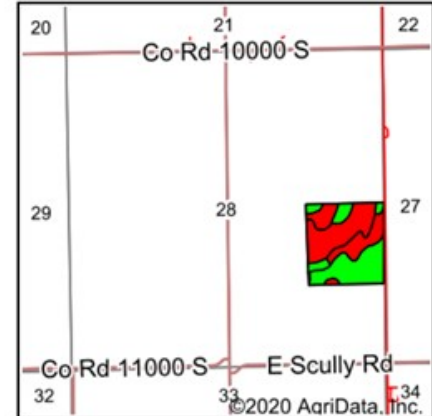
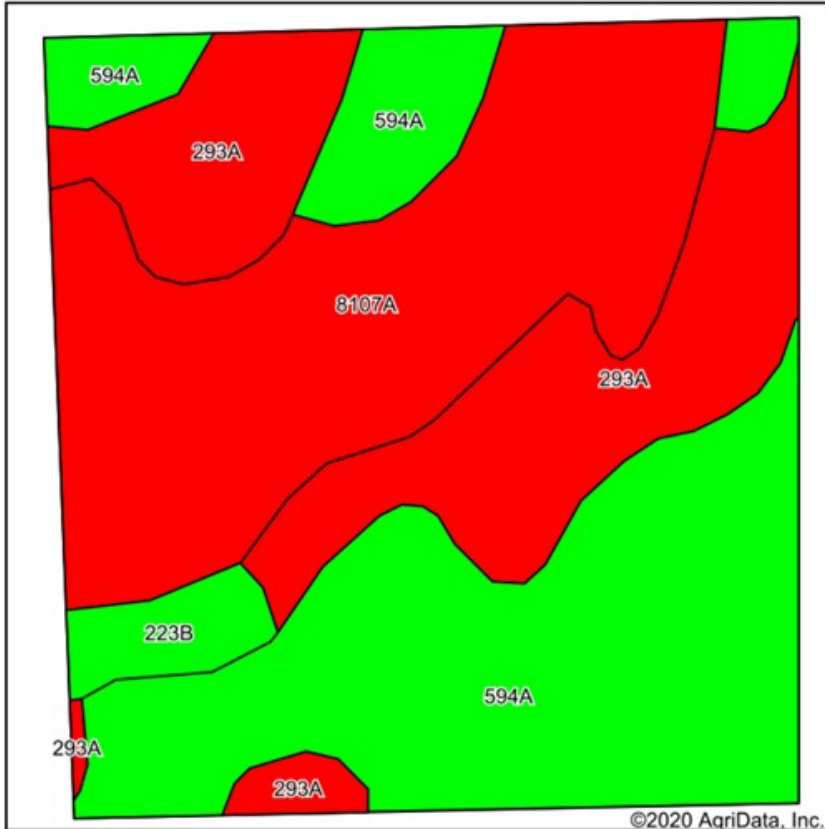


AERIAL MAP 40 ACRE STORM ROAD FARM, GRUNDY COUNTY, IL

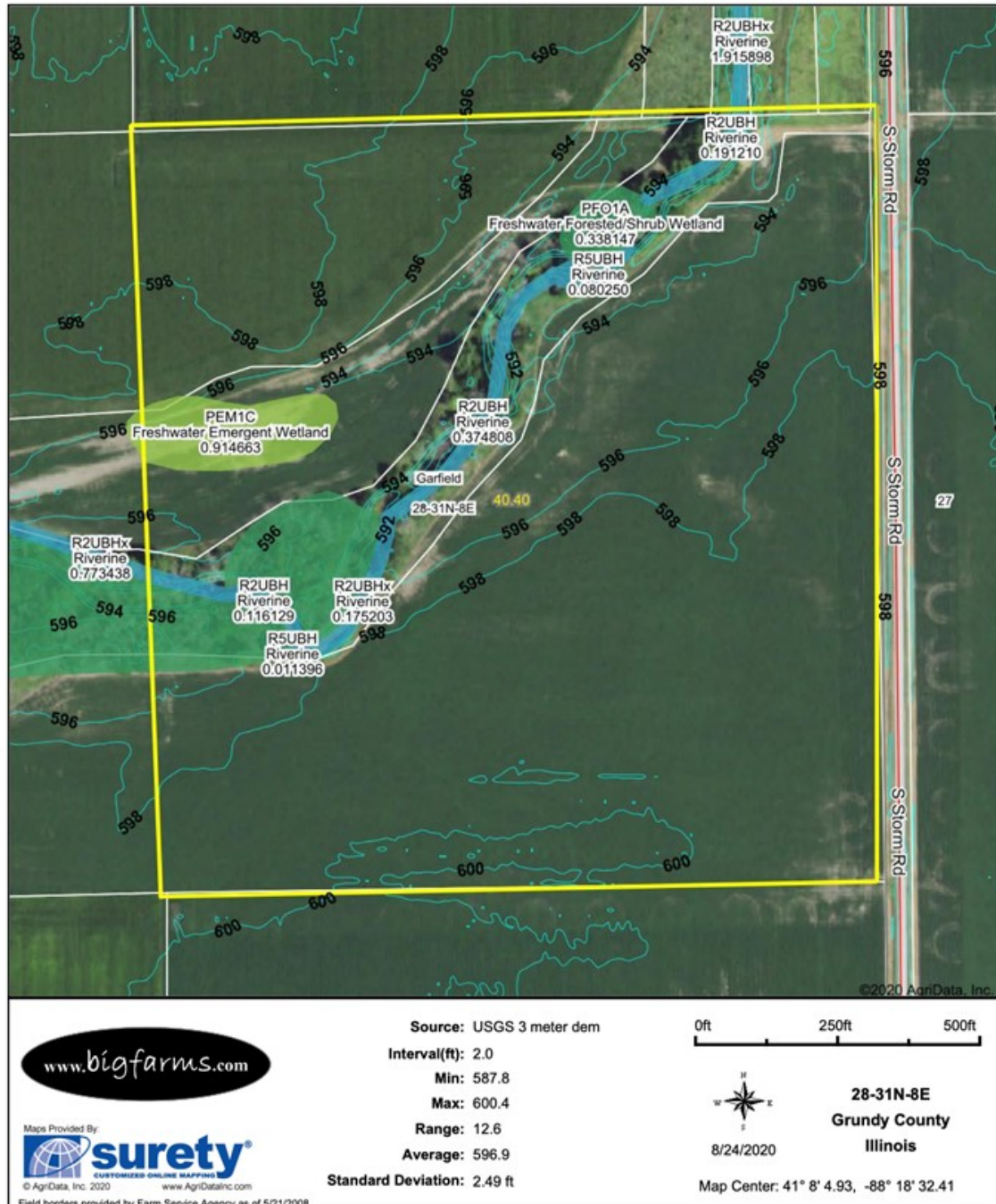
FSA MAP 40 ACRE STORM ROAD FARM, GRUNDY COUNTY, IL

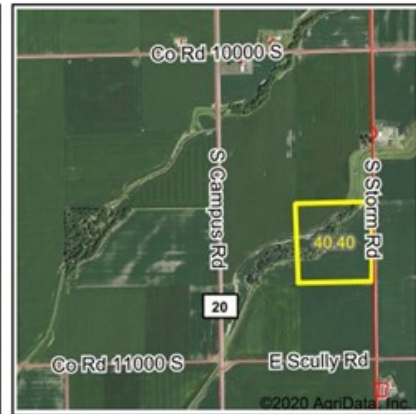
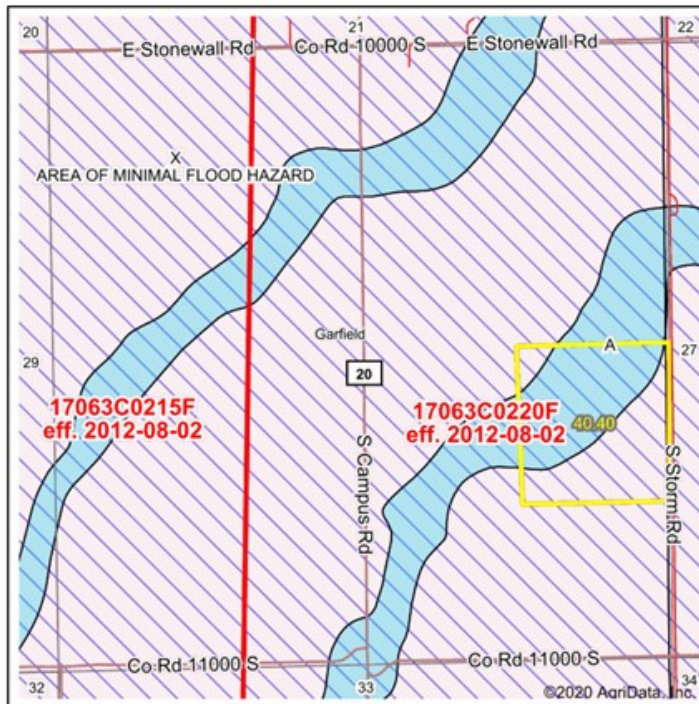
CONTOURS MAP 40 ACRE STORM ROAD FARM, GRUNDY COUNTY, IL

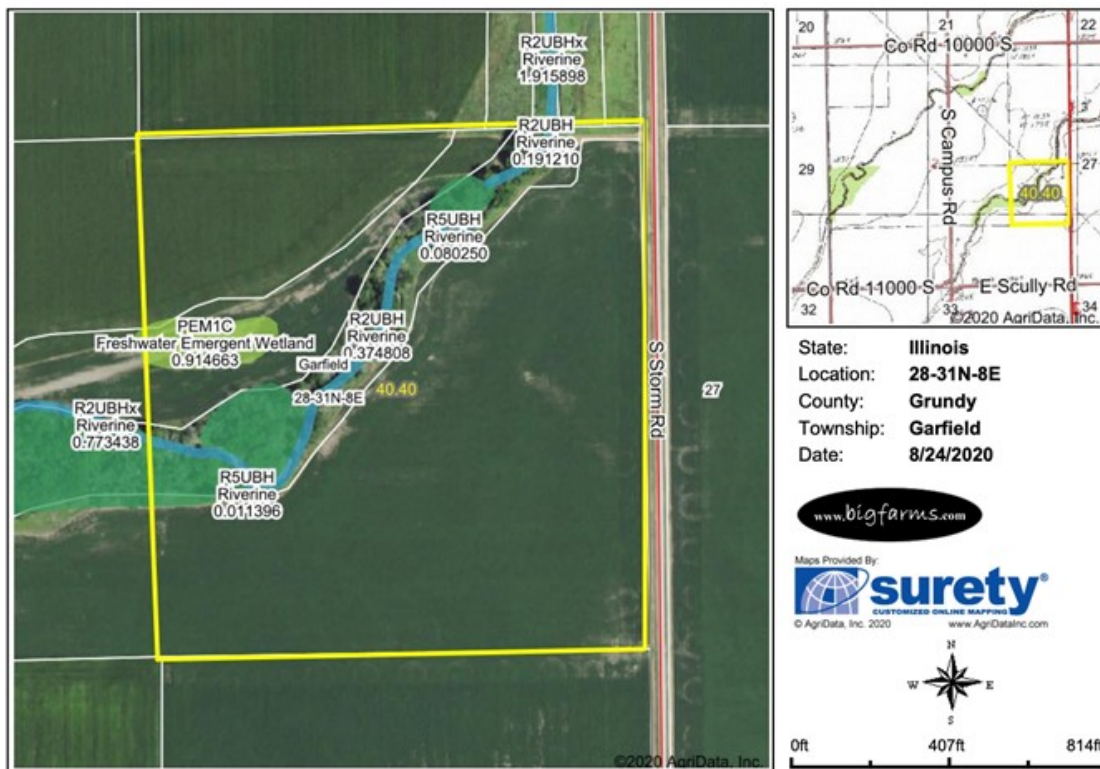

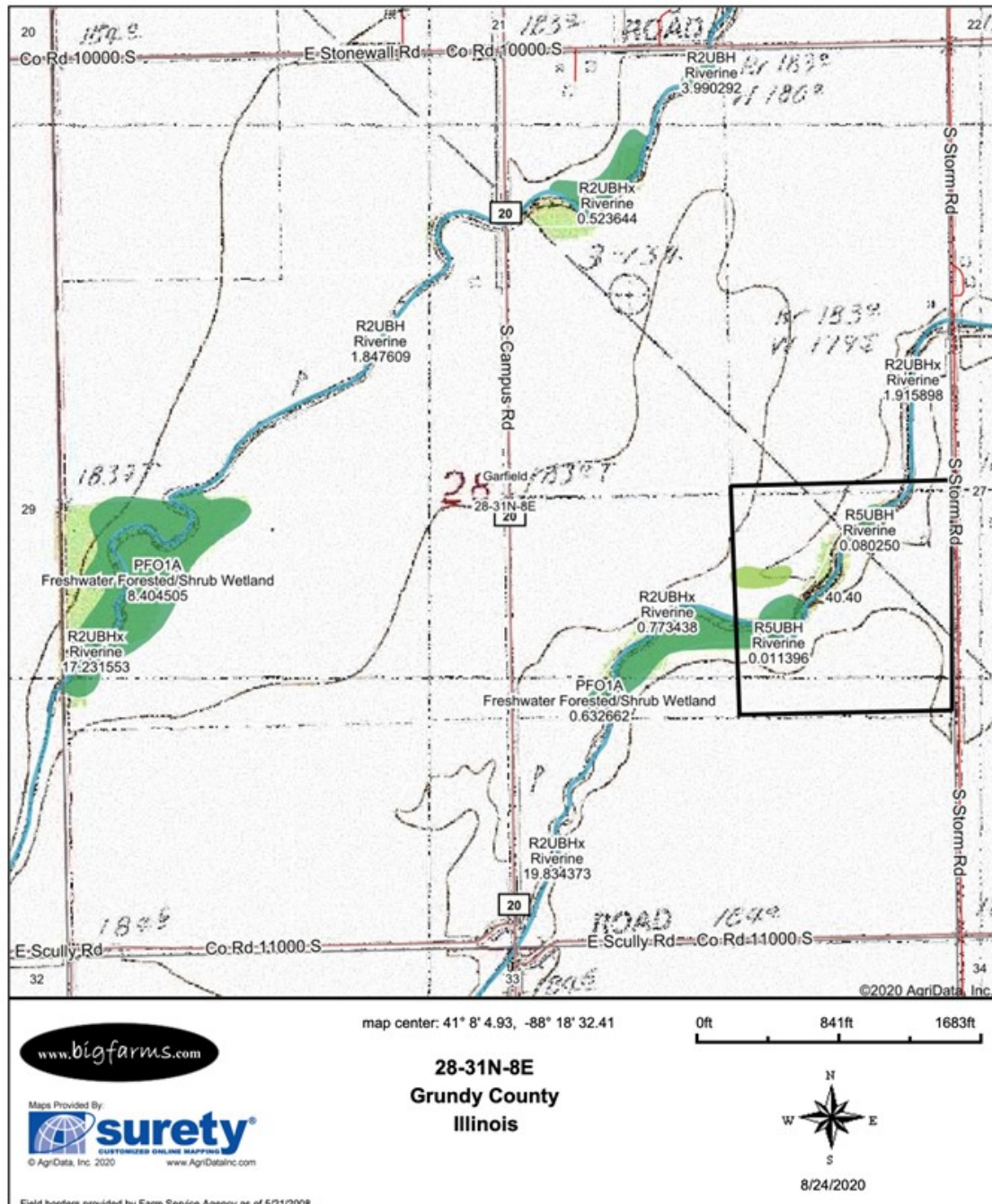

TOPOGRAPHY MAP 40 ACRE STORM ROAD FARM, GRUNDY COUNTY, IL

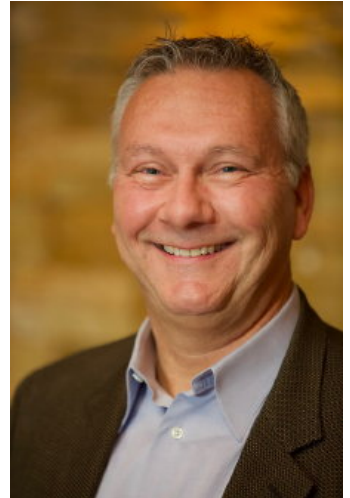
Topography Map
