Highway Access: Illinois Route 38 is located on the south of Parcel 1, Interstate 88 is 1 mile to the south, Illinois

Route 23 is 2 1/4 miles west, Illinois route 64 is 4 1/2 miles north and Illinois Route 47 is 11 1/2

miles east.



#### 63.77 ACRE PLAT MAP IN CORTLAND TOWNSHIP










