Location Description: This 97.9 acre parcel is located 8 miles southeast of downtown Wilmington 2.16 miles north of the

Kankakee River and 9 miles west of Manteno.

Site Description: This parcel has some undulating areas with 97 acres tillable.

Side of Street: The farm sits on the east of S. Mary Btron Road and to the north and south of Manteno road (W.

9000N road)

Highway Access: Interstate I-57 interchange is located 9 miles to the east.

**Road Type:** The road is asphalt construction.

Property Visibility: This property sits on Manteno road which has approximately 2300 cars pass by each day.

Largest Nearby Street: Manteno road is adjacent to the property and Rt. 102 is located 2 miles to the south.

Transportation: Amtrak is 13 miles and Metra is 15 miles away. Kankakee regional airport is 17 miles to the south

and Midway airport in Chicago is 45 miles.



## AREA MAP 97.9 ACRE WESLEY FARM WESLEY TOWNSHIP WILL COUNTY









#### PLAT MAP 97.9 ACRE WESLEY FARM WESLEY TOWNSHIP WILL COUNTY













#### SOIL MAP 97.9 ACRE WESLEY FARM WESLEY TOWNSHIP WILL COUNTY



## Topography Hillshade








## CONTOURS MAP 97.9 ACRE WESLEY FARM WESLEY TOWNSHIP WILL COUNTY

## **Topography Contours**








## TOPOGRAPHY MAP 97.9 ACRE WESLEY FARM WESLEY TOWNSHIP WILL COUNTY








## WETLAND MAP 97.9 ACRE WESLEY FARM WESLEY TOWNSHIP WILL COUNTY
